(2025-2026 Academic Year)

APPLICATIONS WILL ONLY BE MADE ONLINE AND NO DOCUMENTS WILL BE REQUESTED BY HAND FOR ANY REASON.

APPLICATION REQUIREMENTS

Applications are received through the university's candidate application system (<https://ubys.nevsehir.edu.tr/AIS/ApplicationForms/Home/Index?apptype=3>) between the announced dates. Applications of candidates who do not apply during the application period will not be evaluated.

- (1) Applications are made online through NEVÜ official website. Applications, not submitted within the deadline will not be accepted. If there is a difference between the documents uploaded to the system and the originals of the documents, the registration of the candidate is not made. If irregularities are detected, the student's registration is canceled even if the final registration is made and legal action is taken against them. To be able to apply, you must be in the last year of high school or be a graduate.

(2) Applications of candidates in the following situations are accepted.

- a) Application of foreign national candidates
- b) The application of candidates who lost their Turkish citizenship by obtaining a permit to renounce their Turkish citizenship
- c) The application of blue card holder candidates
- ç) The application of candidates with dual citizenship, who have acquired Turkish citizenship and in this situation
- d) The application of candidates from the Republic of Turkey who continued their secondary education abroad before 01.02.2013, who completed the last 3 (three) years of secondary education in a foreign country excluding the TRNC (including those who completed their entire secondary education in Turkish schools opened by the Ministry of National Education in a foreign country other than the TRNC).
- e) The application of candidates who started secondary education abroad after 01.02.2013 and completed all of their secondary education in a foreign country excluding the TRNC (including those who completed their secondary education in Turkish schools opened by the Ministry of National Education in a foreign country other than the TRNC).
- f) The application of TRNC nationals who have completed their secondary education in TRNC and have GCE AL exam results, and candidates who have GCE AL exam results by enrolling in colleges and high schools in other countries between 2005 and 2010

(3) Applications of candidates in the following situations will not be accepted.

- a) Applications of candidates who are citizens of the Republic of Turkey who have completed their entire secondary education in Turkey or in the TRNC.
- b) Applications of candidates with TRNC nationality or dual citizenship, one of which is TRNC. (excluding those who have completed their entire secondary education in TRNC high schools and have GCE AL results, and those who have or will have GCE AL exam results by enrolling in colleges and high schools in other countries between 2005-2010)
- c) Applications of candidates with dual nationality whose first nationality is the Republic of Turkey (except for those who meet the conditions in subparagraphs d and e of Article 2)
- ç) Applications of candidates who are citizens of the Republic of Turkey or whose first nationality by birth is the Republic of Turkey, who have studied at schools affiliated to the embassies in Turkey and foreign high schools in Turkey.

- d) Applications of candidates who apply with a diploma obtained from a high school abroad through distance education without being physically present abroad.
- e) Applications of candidates who are TRNC citizens who have registered to secondary education institutions in Turkey as of the 2022-2023 academic year, who have lost their citizenship of the Republic of Turkey/with blue cards and who are foreign nationals (except for embassy schools and international private education institutions in the MOBIS system)

APPLICATION:

- (1) The explanations regarding the applications are announced on the University's Web Page (<http://www.nevsehir.edu.tr/>).
- (2) Applications are received through the University's candidate application system between the announced dates. Applications of candidates who do not apply during the application period will not be evaluated.
- (3) During the application, the candidate uploads the approved Turkish translation of the application documents listed in Article 4 to the system. The candidate must submit the originals or certified copies of these documents at the final registration stage. The candidate is responsible for the accuracy of the information and documents declared during the application. The applications of the candidates who apply with fake and incomplete documents and, if made, their registrations are canceled and legal action is started against them.
- (4) **The documents to be uploaded and filled in the application system during the application are as follows:**
 - a) "Equivalence Certificate" to be obtained from the Ministry of National Education of the Republic of Turkey, showing that the secondary education (high school) diploma is equivalent to the diplomas obtained from Turkish high schools.
 - b) The original and certified translation of the secondary education (high school) diploma
 - c) Secondary education (high School) transcript and certified translation
 - ç) The original and certified translation of the passport,
 - d) Blue Card document, if any,
 - e) If any, Turkish Foreign Student Admission Exam (TR-YÖS) result document
 - f) If any, the result document of the exams (foreign representation or notary approved) specified in Table 1,
 - g) If available, at least C1 level Turkish Proficiency Certificate according to the Common European Framework of Reference for Languages,
 - ğ) The preference form in the application system (the candidate can make a maximum of 5 preferences),
 - h) Passport photograph (must be taken in the last three months),
 - ı) In accordance with the 4th paragraph of the 9th article of the "International Student Directive" of our university, the students are required to upload a "Financial Assurance Certificate".
- (5) The validity period of the exams in the status of high school graduation exams, which are used in the evaluation of student applications and approved by the Council of Higher Education, are unlimited; however, the validity period of the exams in the status of university entrance exam (ABITUR etc.) is limited to 2 (two) years.
- (6) Candidates of Azerbaijan nationality are required to upload a scanned copy of the Central Examination (TQDK/DİM) exam conducted by the State Examination Center of the Republic of Azerbaijan and its approved Turkish translation to the application system and get at least 500 points out of 700 from the field they are applying for.
- (7) In order to be able to apply to the programs that accept students with the Special Talent Exam, it is necessary to have the result certificate or diploma certificates of the exams specified in Table .1
- (8) The applications made are examined to see if they are suitable, those that are suitable are

approved, and the reason for the non-suitability is entered into the system and the candidate is given time until the end of the application date to correct his/her application. The application of the candidate who does not correct his application by the deadline determined for the end of the applications will not be evaluated.

Applications will be made online only through the link <https://ubys.nevsehir.edu.tr/AIS/ApplicationForms/Home/Index?apptype=3> . Applications by mail will not be accepted.

EVALUATION OF APPLICATIONS

- (1) The University is free to evaluate the applications made and to fill the quotas announced.
- (2) Meeting the application conditions does not require acceptance for placement.
- (3) The relevant special talent exam jury evaluates the candidates who apply to the programs that accept students with the Special Talent Exam.
- (4) A Foreign Student Admission and Placement Committee is established for the purpose of evaluating the applications and making the placements. When selecting international students for each department or program for which a quota is opened, the Commission selects the students with the highest scores among the students who meet the application requirements, according to the priority of the exams included in the Exams and Methods Table (Table 1) in the Application for International Students at Associate Degree and Undergraduate Level. In case of equality in the ranking, placement is made in favor of the diploma grade and junior age, respectively.
- (5) At least 300 points are required for applications via TR-YÖS..
- (6) Among the programs that do not have a quota for the Higher Education Institutions Exam and cannot admit students, those who are allowed to admit international students by YÖK may not place a commission in the programs preferred by a small number of candidates.
- (7) If the information and documents declared during the application are incomplete, incorrect or fake, the registration of the candidates is canceled by the decision of the commission, even if they have registered. Legal action will be taken against them.

If the score written on the Diploma and Exam result documents and the score entered in the system are different, the application of the candidate is cancelled.
