ACCEPTANCE ANNOUNCEMENT OF THE PLACEMENT OF FOREIGN STUDENT IN UNDERGRADUATE AND ASSOCIATE DEGREE PROGRAMS

(2021-2022 Academic Year)

APPLICATIONS WILL BE MADE ONLINE ONLY AND FOR ANY REASON, DOCUMENTS WILL NOT BE RECEIVED BY HAND.

APPLICATION REQUIREMENTS

- 1. Students who are studying or graduating in the last year of a school equivalent to Turkish high schools,
- 2. The applications of the students who score the base score and higher determined by our University mentioned below will be accepted.
- 3. From the candidates;

Candidates whose applications will be accepted on the condition that they are in the last year of high school or graduated;

- a) Foreign nationals;
- b) Those, who are Turkish citizens by birth but who have the permission to renounce Turkish citizenship from the Ministry of Internal Affairs and their children under age who are registered in the certificate of renouncement of Turkish citizenship, documented that they have a Document on the Use of the Rights Recognized in accordance with the Turkish Citizenship Law,
- c) Those who later acquired citizenship of the Republic of Turkey / those with dual citizenship in this situation,
- d) (I) Those who completed the last three years of their secondary education (high school) in a foreign country except TRNC among Turkish nationals who continued their secondary education abroad before 01/02/2013, (including those completed secondary education (high school) in Turkish schools opened by the Ministry of Education in a foreign country except TRNC)
- (II) Those who started their secondary education abroad after 01/02/2013 and completed their secondary education (high school) in a foreign country except TRNC (including those who completed their secondary education (high school) in Turkish schools in a foreign country except TRNC)
- e) Those who are TRNC citizens and reside in the TRNC and have completed their secondary education in the TRNC and have GCE AL exam results, and those who have or will have GCE AL exam results by enrolling in colleges and high schools in other countries between 2005 and 2010, will be accepted.

From the candidates;

- a) Those who are citizens of Turkish Republic and completed their secondary education (high school) in Turkey or TRNC,
- b) Those who are TRNC citizens and have completed their secondary education in the TRNC and have GCE AL exam results, and those who have or will have GCE AL exam results by enrolling in colleges and high schools in other countries between 2005 and 2010,
- c) Those who are dual nationals but their first nationality by birth is Turkish Republic as defined in clause b of article 3, (except those who fulfill the conditions in item d of Article 1)
- d) Those who are dual nationals but one of their nationalities is TRNC (except those who completed their secondary education in the TRNC and have GCE AL exam results, and those who have or will have GCE AL exam results by enrolling in colleges and high schools in other countries between 2005 and 2010),
- e) The application of those who have Turkish Republic nationalities studying at schools in the embassies site in Turkey and at foreign high schools and those who are dual nationals but their first nationality by birth is Turkish Republic as defined in clause b of article 1 will not accepted. Candidates can choose a maximum of 2 (two) programs in their applications.
- 4. Level of Turkish Language Knowledge of Students: Candidates who have gained the right for final enrollment must document their Turkish knowledge level. Those who have C1 and C2 certificates in Turkish according to the European Languages Common Framework Program level will start their education. Those who do not have a certificate will take the certificate exam at the Turkish and Foreign Language Teaching Application and Research Center of Nevşehir Hacı Bektaş Veli University. Those who do not have at least C1 level

certificate will be considered to be on leave for 1 year. Those who cannot receive a certificate of at least C1 level within one year will be dropped out, and those who receive at least C1 level certificate will start their education.

- 5. Students are obliged to have a health insurance by applying to the Social Security Institution within 3 months from the date of registration. General health insurance premiums are paid by students. After enrolling in the university, students must have the foreigner identification numbers from the Foreigners Department of Nevşehir Police Department and inform the Registrar's Office about the foreign identity numbers. The final enrollment rights of the candidates who are found to be unable to submit the required documents in the registration, misrepresentation or do not meet the criteria will be canceled.
- 6. Candidates who will apply to the Faculty of Fine Arts and Faculty of Education, Physical Education and Sports Teaching that admit students according to the results of the Special Ability Exam, must take the "Special Ability Exam" to be held separately.

APPLICATION:

- (1) Detailed information regarding the applications will be posted on the University Web Site (http://www.nevsehir.edu.tr/).
- (2) Applications will be accepted through the university's candidate application system (http://intstudent.nevsehir.edu.tr/) during the announced dates. Applications of the candidates who do not apply during the application period will not be taken into consideration. After the end of the application period, if deemed necessary, an additional application period can be opened through the decision of the Senate in order to fill the quotas.
- (3) During the application, the applicant will upload the originals of the application documents listed in Article 4 and their approved Turkish translation to the system. At the final enrollment stage, the candidate must submit the originals or certified copies of these documents. If there is a difference between the documents uploaded to the system and the original documents, the candidate will not be enrolled.
- (4) The documents that must be uploaded and filled in the application system during the application are as follows:
- a) The "Certificate of Equivalence" that will be obtained from the T.R. Ministry of National Education showing that the secondary education (high school) diploma is equivalent to the diplomas of Turkish high schools,
- b) The original and certified translation of the secondary education (high school) diploma,
- c) Secondary Education (High School) transcript and its certified translation,
- d) The passport and its certified translation,
- e) Foreign Student Exam result documents, if available,
- f) Exam result documents (to be uploaded by Azerbaijani students) of "Tslsbs Qsbulu uzrs Dovlst Komissiyasının" (TQDK)
- g) Exam results, if available,
- h) Turkish Proficiency Certificate at least C1 level according to the Common European Framework of Reference, if available,
- i) Passport photograph
- j) Preference form in the application system (The candidate can make a maximum of 3 choices.)
- (5) As among the examinations approved by the Council of Higher Education and used in the evaluation of student applications during the acceptance of students from abroad to our university; the validity period of the exams with the status of high school graduation exams is unlimited; however, the validity period of the exams (YÖS, SAT, etc.) with the status of university entrance exam is limited to two years.
- (6) After examining the applications, the appropriate ones will be approved, if not, the reasons for not being suitable will be explained in the system and the candidates will be given 3 days from the end of the application date to correct their applications. The applications of the candidates who do not correct them within this period will not be evaluated.

Applications will only be accepted online from the "<a href="https://intstudent.nevsehir.edu.tr/" link, under the "Foreign Student Application" tab. Applications by post will not be accepted.

EVALUATION OF THE APPLICATIONS

- 1. The evaluation of the applications and placement of the candidates are depended on the university. University is free to fill the quotas announced. Meeting the application requirements does not require acceptance for placement.
- 2. At least 50% of candidates of the foreign student quotas of the university will be placed regarding the Foreign Students Exam (YÖS) scores made up of State Universities of Turkish Republic. For the vacant quotas, placement will be made from the above mentioned national and international exam results, diploma grades and talented athletes artists.

ANNOUNCEMENT OF RESULTS

- 1. Evaluation results will be announced on the university website (http://www.nevsehir.edu.tr/) and from the application system https://intstudent.nevsehir.edu.tr/.
- 2. Candidates who are eligible for final enrollment will obtain their acceptance letters by themselves through the application system in order to obtain a visa with an education validity.
- 3. Results will be announced on 27/09/2021 ENROLLMENT DATES

Enrollments will be made between the dates of 04/10/2021-08/10/2021

If candidates, who are entitled to final enrollment, cannot submit the required documents for enrollment, make a false statement or fail to meet the required criteria, their enrollment will be canceled even if they have the right to final enrollment.
