Applications will only be made online and documents will not be returned for any reason.

A total of 4 applicants will be admitted to the department.

APPLICATION REQUIREMENTS

- Applications will be accepted via the university's candidate online application system
 http://ubys.nevsehir.edu.tr/ during the announced dates stated below. Applications of
 the candidates who do not apply during the application period will not be taken into
 consideration.
- 2. The applicants will not be registered provided that there are inconsistencies between the documents uploaded and the original ones. In case of identification of such an irregularity, the registration will be cancelled even if it is completed/finalized and legal proceedings will be commenced. Any application shall be admitted on the condition that the applicant is either in his last year of study or have been graduated from any institution of high school.
- 3. Applications will be accepted from those who:
 - a) are foreign nationals,
 - b) are native-born Turkish nationals who renounced their Turkish citizenship by approval,
 - c) are blue card holders,
 - d) hold citizenship of other countries by birth; and have gained the citizenship of The Republic of Turkey / hold dual-citizenship,
 - e) are Turkish nationals, who were a high school student abroad before February 1, 2013 and who completed the last three years of their high school education in a foreign country other than Turkish Republic of Northern Cyprus (TRNC) (including those that completed their entire high school education at a Turkish school under the Ministry of National Education (MEB) in a foreign country other than TRNC),
 - f) are Turkish nationals, who started their high school education abroad after February 1, 2013 and who completed their entire high school education in a foreign country other than TRNC (including those that completed their entire high school education at a Turkish school under the Ministry of 2 National Education (MEB) in a foreign country other than TRNC),

g) are nationals of TRNC who reside in TRNC and completed their high school education in TRNC and have taken the GCE AL exam and nationals of TRNC and registered and received education in a high school in another country between 2005 and 2010 and have taken the GCE AL exam.

Documents required for application

Please note that all the documents should be uploaded to the application system with PDF and JPG (photo) formats. Each applicant has 15 MB limit for all the documents to be uploaded to the system.

- a) High School Diploma Equivalency Certificate to be received from the Turkish Ministry of Education which verifies that applicant's high school diploma / education is equivalent to those obtained in Turkey,
- b) The original of the high school diploma and its certified translation,
- c) The original transcript of high school and its certified translation,
- d) The passport and its certified translation,
- e) Blue card copy (if any),
- f) The original or true copy of YÖS examination results (if any),
- g) The original of the exam results specified in Table 1 (if any) and its Turkish translation issued by the Embassy, Consulate, or Notary,
- h) A copy of the Turkish Language Proficiency Certificate proving the level of C1 (if any),
- i) Program selection form filled during online application (the applicant can select 5 programs at most),
- j) A passport photograph taken within the last three months.
- k) Financial Security Document (It is a document showing the student can afford the basic living expenses. All expenses to be covered during the education period fall under the responsibility of students. The University is not supposed to provide international students with bursaries and any financial support, or intercede for financial provision.) The amount needed by the applicant to sponsor for his/ her expenses is determined by the University Senate.
